

## **\$TCP Whitepaper — Appendix F**

*Community Incentives & \$TCP Points*

## 1. Incentive system objective

The \$TCP Points system is designed to reward real, verifiable, and continuous contributions to the growth of the The Crypto Pill ecosystem.

This is not an indiscriminate airdrop system or an aggressive shilling campaign.

Points are used to:

- measure individual contribution over time;
- allocate rewards in a merit-based manner;
- select privileged access (e.g. \$TCP OG PASS, future whitelists, bonus airdrops).

The model is community-first, with clear and transparent rules.

## 2. What are \$TCP Points

\$TCP Points are a non-transferable internal scoring system, used exclusively to:

- determine eligibility for \$TCP rewards;
- access passes, whitelists, or future initiatives;
- distinguish active contributors from passive users.

Points are not tokens, are not tradable, and do not represent direct economic value.

## 3. Participant categories

The system distinguishes between:

- Community Members - Standard users, with no minimum follower requirements.
- Community Influencers - Accounts with  $\geq 500$  real followers (X or equivalent platforms), with verifiable engagement.

Some activities are open to all participants, while others are restricted to influencers in order to prevent abuse and maintain quality.

## 4. How to earn \$TCP Points

### 4.1 Atmos Referral (all users)

By applying the official \$TCP referral code on Atmos:

***Reward: +1,000 \$TCP Points***

Conditions:

- valid for everyone (community members and influencers);
- only applies to active wallets generating real fees;
- inactive or unused wallets are not eligible;
- the referral can be set only once per wallet, according to Atmos rules.

### 4.2 Original posts with engagement (Influencers $\geq$ 500 followers only)

Creation of original posts covering:

- \$TCP;
- the whitepaper and appendices;
- the community-first vision;
- long-term mechanisms.

Requirements:

- original content (no copy-paste);
- official project tag @The\_Crypto\_Pill;
- real engagement (likes, replies, coherent reposts).

***Reward: +100 \$TCP Points per approved post***

Engagement metrics are verified via public statistics (e.g. X Analytics).

### 4.3 Reposts or citations (all users, with limits)

Reposts or citations of official \$TCP content.

Requirements:

- project tag @The\_Crypto\_Pill;
- relevant content (no spam);
- for influencers:  $\geq 500$  followers.

***Reward: +10 \$TCP Points per repost/citation***

Subject to periodic limits (anti-spam).

### 4.4 Promotion in external communities (all users)

Sharing the project in groups, forums, and external communities.

Conditions:

- only where allowed;
- informational, non-aggressive messaging;
- a verifiable reference to the project.

***Reward: +10 \$TCP Points per approved action***

### 4.5 TCP/SUPRA liquidity provision (LP)

Community members who voluntarily support protocol liquidity by providing TCP/SUPRA LP may earn additional \$TCP Points, as recognition for structural support to the ecosystem.

Minimum requirements:

- liquidity provision of at least 10,000 SUPRA, with equivalent \$TCP collateral;
- LP maintained for a minimum period (e.g. 3 consecutive months);
- LP provided without mercenary incentives or aggressive farming.

Reward:

- allocation of \$TCP Points (amount defined and communicated separately based on allocation);
- priority consideration for future initiatives, dedicated missions, reserved whitelists, and evaluation for \$TCP OG PASS eligibility.

Important note: LP provision is voluntary, does not guarantee economic returns, and does

not constitute a promise of automatic rewards. Recognition is tied to the quality and duration of the contribution, not to quantity alone.

## 5. Behavioral guidelines

To maintain quality and credibility:

Not accepted:

- spam;
- aggressive shilling;
- bots or fake accounts;
- multi-accounting;
- misleading content or price promises.

Encouraged:

- educational content;
- constructive discussions;
- onboarding of new users;
- clear explanations of the \$TCP model.

Violations may result in point removal, exclusion from rewards, or loss of future eligibility.

## 6. Use of \$TCP Points

Points may grant access to:

- \$TCP rewards;
- extra airdrops;
- future whitelists;
- \$TCP OG PASS eligibility;
- initiatives reserved for the active community.

Specific thresholds and rewards will be communicated separately and on a progressive basis.

## 7. Transparency and updates

The system:

- follows public rules;
- is discretionary but traceable;
- may be updated to improve fairness and quality.

The goal is not to accumulate points, but to contribute authentically to the growth of the project.
